- 14. I have had sufficient opportunity to read this entire document before signing. I have read the document and understand it and I agree to be bound by its terms.*

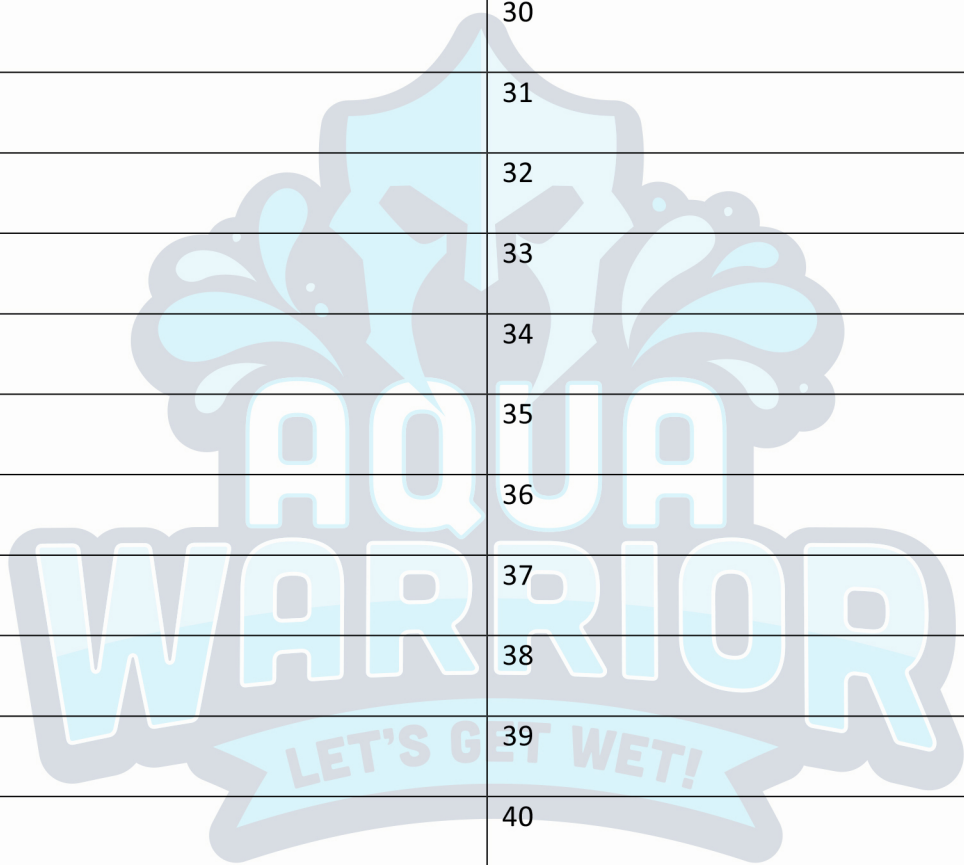
